- 1) **You can apply for joining all teams**, thus increasing the chances of being drawn.
- 2) If your name is drawn to join a team, it cannot be drawn a second time to join a different one. Should that happen, **you will be allowed to join only to the team for which you were drawn in the first extraction.**
- 3) **At 7 p.m. on Friday 9 June 2023**, in the PalaDust, the names of the participants drawn will be communicated and the competition t-shirts will be handed over. **It would be nice if you were present!**





- 4) Once the team is formed, **you will receive a t-shirt for the contest, which you will be required to wear during the performance.** Each team will have a custom-made t-shirt. Once the competition is over, you can keep the t-shirt as a souvenir and an expression of our thanks for your participation.
- 5) On Saturday, 10 June 2023, from 3.00 pm to 6.00 pm for about an hour, **your availability will be required by the team-leading Choreographer in order to prepare the performance.**

- 7) **IMPORTANT DISCLAIMER:** Please submit your registration form **ONLY IF** you know the choreography and are able to perform it. **The Sweat and Dust Country Festival is entitled to disqualify any member of a team who is drawn but does not know the choreography.** A backup participant will be assigned to the team in such cases.
- 8) Saturday 10 June 2023 at 8.00 pm your presence at the PalaDust will be required for the draw of the entrance order and for your accreditation.
- 9) At 9.00 pm the second performance of **THE BEST OF DANCE** at the Swat and Dust Country Festival will start and you will be able to dance with the BIGS!

**Information under Article 13 of Legislative Decree No. 196 of 30 June 2003
“PERSONAL DATA PROTECTION CODE” (IT)**

Rights of the Subject

At any moment you may exercise, under Articles from 15 to 22 of the UE Regulation No. 2016/679, the right to:

- a) obtain from the controller confirmation as to whether or not personal data concerning him or her are being processed;
- b) obtain information on the purposes of the processing; the categories of personal data concerned;
- c) the recipients or categories of recipient to whom the personal data have been or will be disclosed and, where possible, the envisaged period for which the personal data will be stored;
- d) obtain the restriction of processing;
- e) obtain data portability, namely, to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured, commonly used and machine-readable format, and to transmit those data to another controller without hindrance from the controller to which the personal data have been provided;
- f) object at any time to processing of personal data concerning him or her, also where personal data are processed for direct marketing purposes;
- g) not to be subject to a decision based solely on automated processing, including profiling;
- h) obtain from the controller access to the personal data and the rectification or the erasure of personal data concerning him or her, or the restriction of processing, or to object to their processing, besides the right to data portability;
- i) withdraw consent at any moment, without prejudice for the lawfulness of processing based on consent given before the withdrawal;
- j) lodge a complaint to a supervisory authority.
