**Information under Article 13 of Legislative Decree No. 196 of 30 June 2003
“PERSONAL DATA PROTECTION CODE” (IT)**

Rights of the Subject

At any moment you may exercise, under Articles from 15 to 22 of the UE Regulation No. 2016/679, the right to:

- a) obtain from the controller confirmation as to whether or not personal data concerning him or her are being processed;
- b) obtain information on the purposes of the processing; the categories of personal data concerned;
- c) the recipients or categories of recipient to whom the personal data have been or will be disclosed and, where possible, the envisaged period for which the personal data will be stored;
- d) obtain the restriction of processing;
- e) obtain data portability, namely, to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured, commonly used and machine-readable format, and to transmit those data to another controller without hindrance from the controller to which the personal data have been provided;
- f) object at any time to processing of personal data concerning him or her, also where personal data are processed for direct marketing purposes;
- g) not to be subject to a decision based solely on automated processing, including profiling;
- h) obtain from the controller access to the personal data and the rectification or the erasure of personal data concerning him or her, or the restriction of processing, or to object to their processing, besides the right to data portability;
- i) withdraw consent at any moment, without prejudice for the lawfulness of processing based on consent given before the withdrawal;
- j) lodge a complaint to a supervisory authority.
